As I stated in my last email, I will be out of town next week and will not be able to attend the meeting. I have added my lawyer, Joe Levara to this email, and you can reach out to him in my absence. In speaking of my lawyer, we are looking for a 30 day contingency to be able to work on the property. We are looking to start with cleanup of the garbage on the outside, cutting the grass and making the outside more presentable and safer. I know you are looking for a more formal list, but we have not been able to make a full assessment of the property. In one of my earlier emails to you, I stated to you that I have only been notified by you as of this past February, 2024.
